2. To provide well trained faculty/ Teacher for the center as per requirement.

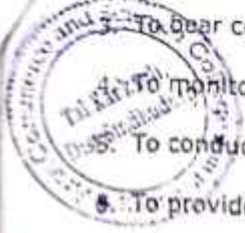

6. To bear center expenses towards Internet Usage Charges at actual.
7. To monitor the training program.
8. To conduct Assessment and provide Certification to successful candidates.
9. To provide job assistance to willing and eligible candidates.
10. To incorporate name and logo of the associating partner in the promotional material for the Center.

**Roles & Responsibilities of S. N. M. Vidyalaya, Kharepatan, Sindhudurga:**

1. To provide rent free Space for training centre (Min. 250 Sq. Ft)
2. To facilitate mobilization of students available at the college as stated in request letter. The association can enroll more number of students than prescribed.
3. To provide the list of enrolled students in advance with the payment of fees to Vedanta Foundation on Quarterly advance basis as stated.
4. To collect the course fees from the enrolled students.
5. To bear other overheads such as Electricity, Water Charges etc.
6. To provide basic facilities such as electricity Usage, Water, Toilet facility for the center free of cost.
7. The Management of the Institute shall form apex committee of Coordinators which will monitor and be responsible for Mobilization of Students from each section and stream. The committee shall consist of one coordinator/ Teacher from Primary/ Secondary Section, Junior Section and Degree- Arts, Commerce and Science Streams. These Teachers / Coordinators shall be responsible for mobilizing required number of students for the Respective courses.

**Terms & Conditions:**

1. The MOU will be valid for the period of 1 Year from the date of signing the same.
2. All the hardware & software will remain under the ownership of 'Vedanta Foundation' and it reserves the right to remove the same after the completion of the batch or expiry of MoU period whichever is earlier.
3. The centre will appoint the faculty who is approved by the Foundation.
4. The centre will follow the approved holidays and allow only the approved and eligible holidays to the faculty without hindering the classes.
5. Attendance of the students as mentioned in the list submitted is mandatory and the maximum time allowed for joining the batch will be 1 Week from the batch start day. The students who fail to join the batch within a week of batch start will

not be allowed to join the batch. The fees of such students will be forfeited and there will be no claim from the associate for any kind of refund for such forfeited amount.

6. In the event of centre not able to provide the targeted students, the foundation may take a decision to close the centre after the tenure of the latest batch. In that event, the advance paid for the next batch fee will be adjusted against the logistics cost and the balance will be refunded to the centre
7. Vedanta Foundation also reserves the right to take back the Hardware provided and call off the association in the situation of the terms & conditions of this MoU are not adhered to and the compensation for the loss of time, energy and recourses shall be imposed on the associating organization.
8. At the end of the MoU time line, the centre should hand over all the assets installed / given by the foundation are to be returned and all dues to be closed 21 days prior to end of MoU time line.
9. In case of any disputes arising out of the circumstances irrespective of whether or not covered in the MoU, decision of Vedanta Foundation authorities will be final and it will be binding on the associating organization. All legal disputes if any will be taken up under Mumbai High court Jurisdiction only.

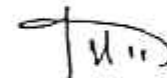

### 3. Roles & Responsibilities – Kharepatan Panchkoshi Shikshan Prasarak Mandal, Kharepatan

- i. Providing a safe & suitable room for setting up the computer lab.
- ii. Providing the required number of electrical points for connecting & setting up of lab.
